A non-refundable booking fee of \$500.00 is payable with contract for each mare booked and the balance of the stud fee of \$1500.00 is to be paid at time of service, or prior to shipping semen in the case of shipping fresh or frozen semen.

Mare care is \$20.00 per day for a dry mare and \$25.00 per day for a Wet Mare. (Not Applicable to Shipped Semen)

Shipped cooled semen is available. In addition to stud fee paid to Kristen Littrell the Stallion Owner, the buyer is responsible for collection and shipping fee paid directly to the Stallion Station:

IF Shipping Semen, Owner is also responsible for their Reproductive Veterinary Team contacting the stallion station listed above concerning the breeding cycle, and ordering semen to ensure that semen will be shipped as needed in a timely fashion. **Please communicate with the reproductive facility as they have a busy schedule and will work to accommodate you if they know you are approaching collection and shipping**

Mare must have a current coggins and be up to date on Vaccinations at time of mare arriving to Valhalla Ranch if live cover has been selected.

Mare must be in good health and breeding sound with Vet Check stating she is healthy

enough to breed.

Valhalla Ranch will only breed approved mares, and reserves the right to refuse service to a mare who arrives in poor condition.

In case of an accident or illness, while the Mare is in the care of Valhalla Ranch, in which a vet is required; the mare owner will be responsible for all charges. Should veterinarian be required, the breeder will call the mare owner as soon as possible for the mare owner to contact the vet of their choice. Should the mare owner not be reached we will choose a veterinarian so that the mare can get proper treatment as soon as possible.

It is understood that stallion owner will not be responsible for accidents, sickness, or death to the mare or substitute and that stallion owner will exercise their judgment in caring and supervising for the mare.

It is agreed that if for any reason the mare does not settle, the stallion owner will be not be held responsible.

It is further agreed that should the above name stallion die or becomes unfit to service, the mare owner has the option to choose from other stallions standing at Valhalla Ranch. In the event of death of the mare or in the event the mare becomes unfit to breed, another approved mare may be substituted .

In the event the mare is not confirmed bred, buyer will be responsible for additional collection and shipping which will be paid directly to the reproductive veterinary facility.

There is a rebreed fee of \$500.00 paid to Kristen Littrell the Stallion owner if the contract is to be carried from one year to the following year.

This contract will become null and void after two years.

If mare is Registered, a copy of mares papers must accompany mare at time of booking.

Mares with shoes on ANY FEET will not be accepted for live cover.

Mares that are not halter broke will not be

accepted for service.

Mare owner will be responsible for vet check for pregnancy and costs associated with all mares veterinary care including but not limited to reproductive, maternity, and foaling.

Live foal guarantee. This contract is for ONE live foal. Mare owner must check for pregnancy at 14 days and then a heartbeat check, along with following recommended veterinary advice for additional reproductive care. IF there are any additional foals born as a result of this breeding, the mare/foal owner is required to pay an additional stud fee associated with each foal. A live foal is to stand and suck its first milk, if a foal dies this guarantee will apply only with the statement of a licensed vet, within one week of foaling and will entitle owner to a free service for the next year or same year to same mare or alternate mare. Mare Owner will be responsible for mare care or charges associated with collection and shipping semen.

A breeders certificate or any and all paperwork to mare owner will be provided upon

notification of the birth of the foal and all bills on mare have been paid, so that you can register your foal in desired and eligible registry. Mare/foal owner is responsible for any and all registration and associated fees for foal.

If mare is sold in foal, Kristen Littrell, Valhalla Ranch does not transfer obligations of this contract unless previously discussed and written in this contract.

If mare is not a registered Gypsy, and said breeding results in a Colt (stud), it is understood that owner agrees to geld the colt when both testicles drop and before he breeds any mares.
